## **New Hartford Capital Expenditures**

**MOTION:** by Coates, second Tuxbury to reduce the Bridge Improvements capital line item from \$214,000 down to \$144,000. Changing the description of the line to Maple Hollow Bridge, adding a footnote stating \$40,000 for that line will be supplemented from the Capital Reserve Account and \$30,000 from the 2013/14 bridge capital account.
