# Board of Selectmen Regular Meeting Tuesday, October 22, 2013 MOTIONS ONLY

Selectman Kennerson asked that a modification be made to the discussion that occurred regarding septage acceptance at the Wastewater Treatment Plant. Page 5, second line currently reads ".....explained the limitations..."

Kennerson asked that it be changed to include a bigger description of the limitations so that residents have a better understanding of the process and can understand why septage disposal needs to be limited. The minutes are clarified as follows: ...."explained the limitations. Mr. Michaud stated that raw septage that comes from septic system pumping is more highly concentrated than sewage that is carried to the plant via sewer lines. There are naturally occurring biological processes that occur in the breakdown of raw septage. This process cannot be forced and the higher the concentration, the more involved and lengthy this process is, thus the limits are not mechanical, equipment or personnel related; they are biologically imposed."
