- The increase in bear activity in the district has been noted by several residents and is of concern to all. The resident next door to the Kinnes at 411 Main Street may be putting out food and water for "wildlife". Giant Steps, the daycare center, has reportedly raised the height of their fence in response to the increase in wildlife traffic (bear, coyote, fox). Gary will contact Town Hall to explore options. This is a serious safety issue for children and pets.

Old Business
