C. Old Business

- Board of Finance Update- Jenn Benaitis talked to Jim Fitzgerald earlier in the day.
 Nothing is concrete but the indication is that the state will not pass on to the town the teacher's pensions. It has yet to be voted on, though.

Motion by Penny Miller to increase Oak Hill from 2 classrooms to 3 classrooms for their 2017-2018 school year at an income to the town for \$132k, second by Jen Benaitis. All in favor, none opposed. The recommendation is to allow the board the ability to cut the position if the state cuts go through. The non-renewal includes Andrea Bennett, Rachel Juliano, Shannon Lasse, Rachel Savage, Ariel Schroeder, and Colleen Toohey.
- b. Possible action regarding superintendent's recommendations for non-renewal of employment contracts- Motion by Jenn Benaitis that the contract of employment of Andrea Bennett, Rachel Juliano, Shannon Lasse, Rachel Savage, Ariel Schroeder, and Colleen Toohey not be renewed for the following year upon its expiration at the end of the 2016-2017 school year and the superintendent of schools is directed to advise such people in writing about this action, second by Josh Adams.
