#### **Old Business:**

## **Superintendent Report:**

1. Budget Presentation - Superintendent Murphy presented to the Board, his budget plan for the 2017-2018 school year. A budget with a 1.9% increase is being proposed. After the presentation, the Board had opportunity for questions.

#### **Communications to the Board:**

- 1. Letter was read from Maria Moore. She expressed a concern about three additional construction projects totaling more than \$700,000 that are not included in the scope of the construction projects at Antolini School for which taxpayers approved funding at a town meeting. The letter went on to request an appointment of a Board of Education member to the School Building Committee on an interim basis until that person can be confirmed at town meeting.
- **2.** The Board received a 2<sup>nd</sup> letter from Jim Fitzgerald. His letter stated the proposed cuts in ECS as well a proposed shifting of responsibility for teachers retirement funding.

# **Opportunity for Public Comment:**

**Tim Goff** (50 Birdsview Ave) – expressed concerns about the fuel line item in the budget and concern for the approval of the teacher's contract.

#### **Reports:**

**Adhoc Committee Update –** Karl Hermonat updated the Board saying that Milone & MacBroom had presented their report in December and due to inclement weather and school cancellations, a January meeting had been cancelled. He reported that the next scheduled meeting would be on the 15<sup>th</sup> of February. Cindy Duval inquired about the possible recommendation by the Adhoc Committee to the Board of Education before for the Board of Ed March meeting.

## **New Business:**

 Discussion and possible action concerning the tentative agreement reached with the New Hartford Education Association for a successor collective bargaining agreement:

  Motion by Josh Adams, 2<sup>nd</sup> by Staci Cull to accept Jen Zenuh as the appointed representative to the Capital Expenditures Committee. All in favor. Motion passes
- **4. School Building Committee** After lengthy discussion about the need for Board representation to this Committee there was a *Motion* by Josh Adams directing the Board of Education Chairman to request the Board of Selectman schedule a Town meeting for the purpose of appointing a Board of Education member to the School Building Committee, 2<sup>nd</sup> by Mary Misiorski. All in favor. *Motion passes*.
