  - a. Budget Transfers- Brian Murphy went over the 7 line items in the Budget Transfers packet. **Motion** by Josh Adams to make the line item transfers as presented, second Stacie Cull. All in favor, none opposed. **Motion passes**
- E. Communication to the Board
  - a. Communication from Board of Finance on June 14,2017- (see below) restated the previous budget cuts passed on from the Board of Finance to the Board of Education and addressed the cuts that are to be implemented as directed by the BOF.
- F. Old Business
  - a. Budget 2017/2018- Pat expressed concern about the BOE being stuck if the BOF follows through with the previously present budget cuts and the BOE has not made changes to their budget to reflect those cuts. Karl recommended the BOE send a letter stating that

On May 9, 2017, the Board of Finance by majority vote, passed a motion that resulted in budget cuts to the Fiscal Year Budgets for 2017-2018 (July 1, 2017 to June 30, 2018). The cuts were as follows;

New Hartford Board of Education Operating Budget: Cut - \$295,497 (not yet implemented)

BOE Capital Budget: Cut -\$ 45,000 (-\$25,000 Technology Wireless Infrastructure, -\$10,000 Mower and -\$10,000 Genie Light Changer), (not yet implemented)

New Hartford General Operating Budget: Cut of -\$145,937 (cuts implemented)

**Town Capital Budget: Cut of -\$232,000 (cuts implemented)** 

Last night at the Board of Finance meeting, member Witte questioned if the BOE implemented the cuts as directed. Acknowledgement from Superintendent Murphy that the Board of Education has not implemented the cuts / reductions to its' 2017-2018 budget is very troubling. As mentioned last night, with the action the BOE took at its May 16, 2017 Special Meeting, the BOE is misleading the public. You must not give the impression to the public that you have only cut -\$96,000 from the operating budget and only -\$20,000 from the BOE Capital. Your cuts are, -\$295,497 operating and -\$45,000 capital. Brian & Jennifer, please take immediate action, the BOE is to implement the cuts as directed by the Board of Finance.
