Ms. Wieduwilt said that some do but they don't respond and they just ignore the bills. Ms. Wexler said you are certifying to us that these are uncollectable taxes and should be suspended to the suspense tax book. Ms. Wieduwilt said that they should. She continued by saying these are sent to the collection agency, TaxServ, and they start collection processes. Sometime they are successful and other times they are not. Mr. Charest asked how long do they stay on the suspense list. They stay on the list for 15 years. The collection rate is 18% / year.

Bookkeeper: Revenue & Expenditures Fiscal YTD and previous fiscal YTD First Selectman's Report

First Selectman Jerram reported that notification has been received that the MUNI Grant for \$139,000 was being released. Mr. Jerram reported the he did file today and has started the application process with FEMA for COVID related expenses. While the town doesn't have a lot of related expenses, Superintendent Murphy had said that he has does. The town crews are now doing some work on Stub Hollow Rd. Mr. Jerram continued by saying it was nice to have the budget done.

Ms. Wexler asked about payments to the library. Mr. Jerram said that some funds have been released. Ms. Wexler asked about if there was a deal with the state for PPE to hand out. Mr. Jerram replied that this has been done. Any business that needed this equipment would file with the CBIA. Once CBIA approved the requested items were picked up at the Goshen Fair Grounds. So far items
