- 4. Staffing Concerns
 - Eileen is working with the lifeguards to see what coverage we have through the end of the season.
 - Jenn discussed a few things to add to the Staff evaluation form that Penny emailed to each commission member.

- Mike discussed new picnic tables. Jenn will bring in a brochure to look at pricing.
- Andy brought up a sill plate on the building that is rotting. It should be addressed soon.
- Andy discussed using garden hoses on the docks. Penny will look into pricing.
- Andy discussed possibly replacing the hardware on the swing set at the end of the season.

6. Equipment –

- Andy is working on getting more coolers for water for the guards and supervisors.
- Penny will get more cases of water for the Cove.

7. Correspondence –

- Andy will send a response email to a patron inquiring about the senior rate increase this season.
- Penny will inquire again and see if we are supposed to pay bounced check fees being a non-profit organization.
- Penny Miller made a motion to add Erik Perotti as an additional signer on the checks for the checking account. Jenn seconds. All agreed. Motion passed unanimously.
