- Meeting called to order 6:02pm
 - Review/approve outstanding meeting minutes
 - Motion by Penny Miller to table review of previous meeting minutes until next meeting; second – Daria Hart
 - Motion passed unanimous
- Old Business
 - Budget proposal
 - The Cove has declining income for the last three years.
 - Daria Hart proposed a budget for 2016; estimated income based on increases in pass prices and approximate number of passes sold historically; expenses include tree maintenance.
 - Motion by Penny Miller to accept the 2016 Stanclift Cove budget as proposed; Second by Doug Simpson
 - Motion passed unanimous
 - Daria will put budget in the proper format and send to Annie Witte
 - 2016 Flyer approval
 - Daria proposed 2016 Flyer Draft; Board and public reviewed and discussed
 - Motion by Penny Miller to accept the 2016 Stanclift Cove Flyer as amended; Second by Doug Simpson
 - Motion Passed Unanimous
 - Daria Hart received permission to print in NH Town Hall
 - Motion by Penny Miller to print up flyers and other items in NH Town Hall with Stanclift Cove Authority supplying paper and toner supplies; second by Kim Fiducia
 - Motion passed Unanimous
 - Staffing
 - Goal to post and accept jobs by 15 April; thus far previous employees have been notified
 - Supervisors 5 applications received; need at least 4, possibly 5
 - Guards 4 applications received; need 14
 - Motion by Daria for Carlene Jerram and Penny Miller to evaluate and hire staff for 2016 season with Doug Simpson's help for guard evaluation; Second by Kim Fiducia
 - Motion passed Unanimous

- Prep for Opening
 - Clean up Kim contacted Vo Ag and will make a poster for NWR7 to post
 - Mike will help supervise
 - Saturday afternoon target 23 and 30 April, 10am to 3pm
 - Will be open for supporters from towns
 - Storage back of shed is rotted; possible Eagle Scout project?
 - Drainage Mike addressing
 - Fire pits will review for safety; must have solid base
 - Trees removal and cabling
 - The towns of New Hartford and Barkhamsted are supporting the initial tree removal and maintenance effort \$12,125 each as follows:
 - Tree removal \$18,050, split \$9,025 per town
 - Tree maintenance \$6,200, split \$3100 per town
 - Through DPW and Weso Tree Service
 - Kim Fiducia and Daria Hart will start working on a planting plan; will consult conservation commissions and arborist about appropriate mix of planting, when and how
 - Need to rescue the small picnic table from the water
- New Business
 - Education Connection Contract
 - Discussion used about 5 hours last year based on \$330 spend in budget
 - Motion by Daria Hart to approve contract for Educations Connections services not to exceed \$500; amend motion to not to exceed \$400. Second by Penny Miller
 - Motion Passed Unanimous
 - Bathrooms Christine from Russ's Septic approached Kim; offered to do some fundraising to improve bathrooms
 - Ideas to raise funds Donate from Russ's jobs, dunk booth at New Hartford Day, other
 - Ideas for improvements: Increase size of bathrooms to include changing areas; repairing the building; walls ventilation, prettier, new skylights, ADA ramp to door
 - Daria indicated we cannot change the building but can repair (cited MDC easement)
 - Need to firm up what they propose to do Kim
 - Who will make the improvement
 - What do we need to do to be accountable?
 - Add to the Agenda

 - Amy Sharon of Still Life Photography requests use of the Cove for Barkhamsted PTO family portraits 14 May2016
 - Mike will open for Amy Sharon

 - Motion by Daria Hart to approve the use of the cove for Still Life Photo to support the Barkhamsted PTO for a few hours on 14May; second by Penny Miller
