ITEM NUMBER 1:

Moderator Smith opened the floor for discussion on the only item. With no comments from the floor, Moderator Smith gave the floor to First Selectman Dan Jerram. First Selectman Jerram explained that about a year ago, the owners of the property approached the town about donating the property known as 4 Cottage Street (Map and Photos – Attachments 1 and 2). The town required the owner to complete an environmental review with proof that there is no pollution on the site and provide a title insurance policy (Deed and Title Insurance Policy – Attachment 3). The acquisition was approved by Board of Selectmen at their meeting on September 23, 2014 (BOS Minutes – Attachment 4). The acquisition was presented to the Planning and Zoning Commission on September 24, 2014 (P&Z Minutes – Attachment 5). The Planning and Zoning Commission also approved the acquisition indicating compliance with the Plan of Conservation and Development pursuant to the provisions of Connecticut General Statute Section 8-24. First Selectman Jerram further stated the reason for accepting this parcel is for public safety to improve the intersection at the end of Cottage Street and access to Callahan Park.

Paul Pobuda inquired whether this parcel would align Cottage Street with Greenwoods Road. First Selectman Jerram indicated that Cottage Street would more likely align with Prospect Street.

Selectman Alesia Kennerson asked that the tax information be entered into the record. First Selectman Jerram stated that the Tax Collector had confirmed that the taxes are paid on the parcel. The annual property taxes on this parcel are \$102.69.

Moderator Smith called for a voice vote to accept the parcel.

Paul Pobuda made a point of order that there was no motion on the floor to be voted upon. Moderator Smith asked for a motion to accept the parcel of land known as 4 Cottage Street.

Motion Paul Pobuda, Second Carlene Jerram to accept the parcel of land known as 4 Cottage Street. Unanimously approved by voice vote.

Moderator Smith announced having no other business on the agenda, may I have a motion to adjourn?

Motion Paul Pobuda, second Noel Gauthier to adjourn.

Unanimously approved.
