All water usage will be billed at \$7.88 per thousand gallons<sup>1</sup>

<sup>1</sup> \$2.25 per thousand gallons of the total usage rate will be used to service debt incurred for capital improvements to the water supply and distribution system.

## **SEWER USAGE CHARGES**

Sewer usage will be billed at \$20.38 per thousand gallons subject to the following minimum charges.<sup>3</sup>

### Minimum Charges:

Metered customers: \$127.38 (6,250 gallons) per quarter

Non-metered customers: \$366.86 (18,000 gallons) per quarter

<sup>3</sup> \$4.05 per thousand gallons of the total usage rate will be used to service debt incurred for capital improvements to the sewer collection and treatment system.

## **NEW SEWER CONNECTION CHARGES**

1-unit residential connection	\$250 per application to connect
2-unit residential connection	\$300 per application to connect
3- or more unit residential, commercial, industrial, or other connection	Cost of processing the permit to connect, to be established on a case-by-case basis to cover engineering review and field inspection.
