Good Morning First Selectman Jerram,

We are in receipt of the subject proposal with supporting information sent during the past year and appreciate your time, energy and patience during our review.

After full consideration your request for grant forgiveness has been approved pending payment in full of all Agency direct loans. The reasoning is supported by Executive Order (E.O.) 12803 Infrastructure Privatization, which notes that *"State and local governments should have greater freedom to privatize infrastructure assets (and)...dictates that the Agency shall encourage appropriate privatization of federally financed infrastructure assets owned by state and local governments."*

With the above in mind, this approval has been formalized and recorded internally and is conditioned only upon repayment in full of Agency loans.
